

## **Shopping & Shop Fronts Supplementary Planning Document**

### **ADOPTION STATEMENT**

Hinckley and Bosworth Borough Council adopted the Shopping & Shop Fronts Supplementary Planning Document on Tuesday 30<sup>th</sup> October 2007. This adoption statement is required by Town and Country Planning (Local Development) (England) Regulations 2004 (Regulation 19).

Any person aggrieved by the Shopping & Shop Fronts Supplementary Planning Document may make an application to the High Court for permission to apply for judicial review of the decision to adopt the Supplementary Planning Document. Any such application for leave must be made promptly and in any event not later than 3 months after the date on which the Supplementary Planning Document was adopted.

**Title of Document:** Shopping & Shop Fronts Supplementary Planning Document (SPD).

**Subject Matter:** The Shopping & Shop Fronts SPD provides supplementary guidance on saved Local Plan policies BE1, 9, 10 & 11 and Retail 2, 3, 4, 6 & 8 in relation to retail development.

**Geographical coverage:** The Shopping and Shop Fronts SPD relates to the entire Borough of Hinckley and Bosworth but with a particular focus on Hinckley Town Centre.
