ENFORCEMENT NOTICE

ISSUED BY HINCKLEY & BOSWORTH BOROUGH COUNCIL

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to it that there has been a breach of planning control, under section 171A(1)(a) of the above Act, at the land described below. It considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

The Land at Manor Hill Farm, Leicester Lane, Desford, Leicester, Leicestershire ("the Land") which is shown edged red on the plan annexed ("the Plan").

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without planning permission the material change of use of the land from agriculture to use for the storage of building materials

4. REASONS FOR ISSUING THIS NOTICE

a) In the opinion of the Local Planning Authority the change of use of the land from agriculture to the use for the storage of building materials within the open countryside introduces an incongruous and unsustainable form of development

which would have a significant adverse impact on the intrinsic value, beauty, open character and landscape character of the countryside and is contrary to Policy DM4 and DM10 of the Site Allocations and Development Management Policies DPD.

b) It is also evident to the Local Planning Authority that this use began less than ten years ago and it is therefore expedient for the Local Planning Authority to take enforcement action to remedy the breach of planning control.

5. WHAT YOU ARE REQUIRED TO DO:-

- a) Cease using the land for the storage of building materials
- b) Remove all building materials from the land

6. TIME FOR COMPLIANCE:

One month after this notice takes effect.

7. DATE WHEN THIS NOTICE TAKES EFFECT

This notice will take effect on 20 March 2018 unless an appeal is made against it beforehand.

The enclosed leaflet "HOW TO COMPLETE YOUR ENFORCEMENT APPEAL FORM" sets out your rights and how to lodge your appeal. If you wish to lodge an appeal you must contact the Planning Inspectorate in the first instance for the forms to be sent to you.

If you appeal and wish the appeal under ground (a) or the deemed planning application to be considered a fee of £924.00 is payable. Fee must be paid to the Council (cheque made payable to Hinckley & Bosworth BC). The Planning Inspectorate will notify you of the date by when this fee must be paid.


WHAT HAPPENS IF YOU DO NOT APPEAL


