1. On the **17th March 2022** the Council has issued this Temporary Stop Notice alleging that there has been a breach of planning control on the Land described in paragraph 4 below.

2. This Temporary Stop Notice is issued by the Council, in exercise of their power under section 171E of the 1990 Act, because they think that it is expedient that the activity specified in this notice should cease on the Land described in paragraph 4 below. The Council now prohibits the carrying out of

the activity specified in this notice. Important additional information is given in the Annex to this notice.

3. THE REASONS FOR ISSUING THIS NOTICE

- a) Unauthorised material change of use of land South of Lindley Wood, Fenn Lanes, Fenny Drayton, Leicestershire for siting of a mobile home, along with storage use (B8 Storage & Distribution) including the parking of HGV lorries for commercial use.
- b) That it is expedient to take enforcement action because the Council consider that:
- i. The unauthorised use taking place on the Land should cease in the light of the absence of the necessary planning permission for the development taking place.
- ii. The current use of the Land is considered to cause a danger to highway safety as a result of HGV lorries coming and going form the Land along a very narrow single access track off Fenn Lanes which is also shared by residential properties and agricultural traffic.
- iii. The unauthorised use of the Land has an unacceptable adverse impact to the amenities of neighbouring residents by reason of noise and traffic

4. THE LAND TO WHICH THIS NOTICE RELATES

Land South of Lindley Wood, Fenn Lanes, Fenny Drayton, Leicestershire, ("The Land") outlined in red on the attached plan ("The Plan")

5. THE ACTIVITY TO WHICH THIS NOTICE RELATES

The unauthorised material change of use of the Land for siting of a mobile home, along with storage use (B8 Storage & Distribution) including the parking of HGV lorries for commercial use.

6. WHAT YOU ARE REQUIRED TO DO

Cease the unauthorised use taking place on the Land, along with the use of the Land for the siting of a mobile home.

This excludes any work required to make safe any activity required to cease as a result of this Notice.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes immediate effect, when all the activity specified in this notice must cease.

This notice will cease to have effect 28 days after the date this Notice takes effect.

ANNEX

WARNING

THIS NOTICE TAKES EFFECT ON THE DATE SPECIFIED IN PARAGRAPH 7.

THERE IS NO RIGHT OF APPEAL TO THE SECRETARY OF STATE AGAINST THIS NOTICE.

It is an offence to contravene a temporary stop notice after a site notice has been displayed or the temporary stop notice has been served on you (section 171E(4) of the 1990 Act). If you then fail to comply with the temporary stop notice you will be at risk of prosecution in the Magistrates' Court, for which the maximum penalty is £20,000 on summary conviction for a first offence and for any subsequent offence.

The fine on conviction on indictment is unlimited. If you are in any doubt about what this notice requires you to do, you should get in touch immediately with the Council's nominated officer:
