#### **ENFORCEMENT NOTICE - OPERATIONAL DEVELOPMENT**

ISSUED BY: HINCKLEY & BOSWORTH BOROUGH COUNCIL ("The Council")

1. THIS NOTICE is issued by the Council because it appears to them that there has been a breach of planning control, within paragraph (a) of section 171A (1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND TO WHICH THE NOTICE RELATES

Land at 39 Wykin Road, Hinckley, Leicestershire LE10 0HU, (the "Land") shown edged in red on the attached plan (the "Plan").

## 3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, the erection of a fence exceeding 1 metre above ground level fronting a highway on the Land (the "unauthorised development"), as shown in the photograph(s) under **Appendix 1** of this notice.

#### 4. REASONS FOR ISSUING THIS NOTICE

It appears to the Council that the above breach of planning control has occurred within the last four years.

The unauthorised development has a significantly harmful effect on the character of the local street scene and general locality due to its height and general overall appearance. Furthermore, due to its height, the fence causes a highway and pedestrian safety risk as it obstructs visibility to the adjoining highway. Subsequently, the unauthorised development conflicts with Policy DM10 (Development and Design) and DM17 (Highways and

Transportation) of the Hinckley & Bosworth Borough Council Site Allocations and Development Management Plan Document (2016) and Part 3, Figure DG17 of the Leicestershire Highways Design Guide and NPPF Paragraph 10.

The Council does not consider that planning permission should be given for this development, because planning conditions could not overcome the objections to the development.

#### 5. WHAT YOU ARE REQUIRED TO DO

a. Remove the fence and associated fence posts in their entirety

Or,

b. Reduce the fence and associated fence posts to a height not exceeding 1 metre from ground level.

#### 6. TIME FOR COMPLIANCE

Three months from the date this notice takes effect.

#### 7. WHEN THIS NOTICE TAKES EFFECT


THE PLAN - 39 Wykin Road, Hinckley, Leicestershire LE10 0HU
