## TEMPORARY STOP NOTICE

1. On **7<sup>th</sup> February 2025**, the Council has issued this Temporary Stop Notice alleging that there has been a breach of planning control on the land described in paragraph 4 below.

2. This Temporary Stop Notice is issued by the Council, in exercise of their power under section 171E of the 1990 Act (as amended), because they consider that it is expedient that the activity specified in this notice should cease on the land described in paragraph 4 below. The Council now prohibits the carrying out of the activity specified in this notice. Important additional information is given in the Annex to this notice.

### 3. THE REASONS FOR ISSUING THIS NOTICE

That it is expedient to take enforcement action because the Council consider that, the unauthorised operational development taking place on the land described in paragraph 4 below, including but not limited to the erection of two

steel structures, along with excavation work, the digging of trenches and provision of some hardstanding (the 'unauthorised works') amount to a significant material operation requiring planning permission (see photographs of unauthorised work at **Appendix A** of this notice). Therefore, any further work should cease with immediate effect to prevent any further unauthorised works taking place without the relevant planning permission.

The Council considers that it is expedient and in the public interest to take enforcement action because the activities constituting the 'unauthorised works', cause significant harm in terms of noise, highway safety and environmental impact on nearby public amenity and the area generally.

#### **4. THE LAND TO WHICH THIS NOTICE RELATES**

Land at Burbage Road, Burbage, Hinckley, Leicestershire, Leicestershire LE10 2TP (the "Land"), shown edged red on the attached Site Location Plan.

#### **5. THE ACTIVITY TO WHICH THIS NOTICE RELATES**

All building/operational development work, inclusive of any new unauthorised uses on the Land.

#### **6. WHAT YOU ARE REQUIRED TO DO**

Cease all activity specified at section 5 of this notice.

This excludes any work required to make safe any activity required to cease as a result of this notice.

#### **7. WHEN THIS NOTICE TAKES EFFECT**

This notice takes immediate effect when all the activity specified in this notice shall cease.

This notice will cease to have effect 56 days after the date of this Notice.

### WARNING

THIS NOTICE TAKES EFFECT ON THE DATE SPECIFIED IN PARAGRAPH 7.

THERE IS NO RIGHT OF APPEAL TO THE SECRETARY OF STATE AGAINST THIS NOTICE.

It is an offence to contravene a temporary stop notice after a site notice has been displayed or the temporary stop notice has been served on you (section 171G(1) of the 1990 Act). If you then fail to comply with the temporary stop notice you will be at risk of prosecution, for which the maximum penalty on conviction is an unlimited fine. If you are in any doubt about what this notice requires you to do, you should get in touch immediately with Council's Planning Enforcement Team, the nominated officer's details are listed below. If you need independent advice about this notice, you are advised to contact urgently a lawyer, planning consultant or other professional adviser specialising in planning matters. If you wish to contest the validity of the notice, you may only do so by an application to the High Court for judicial review.
